	Professional:	σακκοφόροι, <i>sakkophoroi</i> : porters οἱ ἀπὸ τοῦ μετρητοῦ, <i>hoi apo tou metretou</i> : the phrase <i>apo tou metretou</i> derives from the measurement unit of <i>metretes</i> and probably denotes those involved in the trade of products sold and purchased, after being measured accordingly, stationed near the agora where the official measure units were normally kept (Robert 1977: 92).

Note	In Roman Asia Minor the term <i>synedrion</i> is often used in connection to professional associations (Poland 1909: 156-7). In this case the <i>sakkophoroi</i> are organized in a <i>synedrion</i> . The durability of the group is inferred by the fact that they are the recipients of fines in case of the violation of tombs.
