i. Comments	<p>Membership list with names, ages, identifying marks/scars; probably intended to be appended to an association charter like other examples (CAPInv. 1277). Significant space remains on the papyrus where the charter likely was intended to be copied.</p> <p>If Panesneous, son of Harmiusis, is to be identified with one of the members of the association of the <i>apolysimoi</i> of P.Mich. V 244 (CAPInv. 1409), on the basis of his age, this text should be dated some two years after P.Mich. V 244, ca AD 45/6.</p>
