Laws and rules	Failing to help someone in need results in a fine of 8 drachmas, l.6; shoving and taking wrong place at a banquet (εὐοχία <i>euochia</i>) results in a fine of 3 obols, l.6-7; prosecution or slander of another results in fine of 8 drachmas, l.7; intrigue of another or corruption/destruction of the home results in a fine of 60 drachmas, l.8; surety up to 100 drachmas for 30 days, l.9; rules regarding funerals in the event of a member's death: outward display of grief/shaving of hair and hold a feast for one day, for which each member contributes one drachma and 2 loaves, l.9-10; association seems to intend to hold a feast for one day in the event of a death of others (non-members) affiliated with the group somehow, l.10.
