ii. Name elements	Kinship-related:	The association is self-identified as the 'group of relatives'.
iii. Descriptive terms	κοινόν, <i>koinon</i>	
Note	<i>koinon</i> : SEG 24: 473, l. 6	
	It is perhaps noteworthy that both associations securely attested in Epirus (cf. CAPInv. 842) use the very term, <i>koinon</i> , used by the Epirote state and its subdivisions.

iii. Members	The members are called σύγγονοι, <i>syngonoi</i> , "relatives". The term is poetic and rarely used in epigraphic prose.

IX. MEMBERSHIP

i. Number	Four persons are named besides the <i>koinon</i> as dedicants of the monument.
ii. Gender	Men
Note	All four persons identified by name are men.
v. Relations	Kleomachos son of Nikanos, Filisstos son of Lykotas and Nikanos son of Filisstos are obviously related, as expected in a kinship-based collectivity.

X. ACTIVITIES

iii. Worship	On the basis of the dedication to Poseidon, it is possible to suppose worship by the group. On the cult of Poseidon in Epirus, see Franke 1961: 290-4.
