IV. NAME AND TERMINOLOGY

iii. Descriptive terms	σύνοδος, <i>synodos</i> κοινὸν, <i>koinon</i> ?
Note	The term σύνοδος, <i>synodos</i> occurs twice in the text (I.Delos 1521, l. 17; 32). While the text also includes two references to τῷ κοινῷ, <i>toi koinoi</i> (I.Delos 1521, l. 21; 26), it is not so clear whether the word is used to refer to the (same) association. In line 21, it concerns the crowning of honorands and seems to mean 'in public', rather than constituting a reference to the association. In line 26, the words <i>toi koinoi</i> have been understood to mean that a copy of the honorary decree had to be sent to another <i>koinon</i> elsewhere (Fougeres 1889: 241-2; cf. Ziebarth 1896: 43; Poland 1909: 561, no. B 187; Roussel and Launey in I.Delos 1521.). The relevant lines of the inscription (ll. 24-6) are only partly preserved and the suggested interpretation is uncertain.

VII. ORGANIZATION

iv. Officials	While Fougères (1889: 240; followed by Ziebarth 1896: 43) thought the decree mentioned <i>hieropoioi</i> , the reading of the text was subsequently corrected to <i>hieropoik[on]</i> (I.Délos 1521, l. 23, following Roussel 1915-16: 205 with 296). See below: 'Treasury/funds'.
viii. Obligations	The two honorands were admitted to the association without the required introduction or admission fee (ll. 17-18: εἰσόδιον, <i>eisodion</i>) and they were exempt from any payment or liturgy (l. 19: λειτουργία, <i>leitourgia</i>), which suggests that members usually were obliged to make payments / contributions. Cf. Roussel 1987: 92.

VIII. PROPERTY AND POSSESSIONS

i. Treasury/Funds	The association had common funds (I.Délos 1521, l. 23-4: κοινὸν ἀργύριον, <i>koinon argyron</i> ; l. 35: κοινὰ χρήματα, <i>koina chremata</i>), from which the cost of honorary crowns and statues was covered (ll. 33-5) and from which a sum of 50 drachmai was set aside for the day celebrated each year in honour of two honorands (ll. 21-4). The latter sum seems to have been referred to as ἱεροποικ[όν], <i>hieropoik[on]</i> (I.Délos 1521, l. 23, restored; following Roussel 1915-16: 205 with 296; cf. BE 1958.137).
ii. Realty	ἱερόν, <i>hieron</i> (I.Délos 1521, l. 31) -- It is not clear if this sanctuary was the property of the association. Cf. Ziebarth 1896: 43; Roussel 1915-16: 205.

IX. MEMBERSHIP

iv. Status	The decree contains a reference to the month Mecheir (I.Délos 1521, ll. 22-23), which indicates that the <i>synodos</i> had a connection to Egypt. It probably was an association of Egyptian settlers on Delos (Fougères 1889: 241-2; Roussel 1915-16: 204-5; 1987: 92). Their foreign origin seems confirmed by the reference to the good example set to 'others abroad' (ll. 7-8: τοῖς ἄλλοις τοῖς ἐπ' ἄλλοδημίας) by one of the honorands. If the reconstruction of the text in lines 24-6 is correct, a copy of the honorary decree had to be sent 'to the fatherland' (ll. 25-6: εἰς τὴν πατρίδα; following Holleaux 1899: 10-11, no. 10).

X. ACTIVITIES

ii. Meetings and events

The association must have held regular drinks parties or banquets (πόσεις, *poseis*), since the honorary decree states that at any such celebration (Il. 19-20: καθ' ἐκάστην πόσιν, *kath' ekasten posin*), both honorands were to be crowned. Furthermore, a day in honour of the two honorands was celebrated each year in the month Μεχέρ, *Mecher*. See below: 'Honours/other activities'.

iv. Honours/Other activities

I.Délos 1521 contains a decree (Il. 12ff.) outlining the honours awarded to two people. Their identity is unknown; Roussel and Launey (in I.Délos 1521) suggest that they were father and son. Both are crowned / honoured with a golden crown (l. 14: *chrysos stephanos*) and a bronze statue (l. 15: *eikon chalke*) which is to be set up at a place of their choosing. They are to be admitted (l. 16: προσλάβεσθαι, *proslabesthai*) to the association (synodos) without the required introduction or admission fee (Il. 17-18: εἰσόδιον, *eisodion*), receiving an honorary seat (l. 18: klisia), and being exempt from any payment or liturgy (l. 19: λειτουργία, *leitourgia*); at each drinks gathering or banquet (l. 20: πόσις, *posis*) both men are to be crowned along with a proclamation (l. 21: ἀναγόρευσις, *anagoreusis*); a day is also to be held in their honour each year in the month Mecher, for which a sum of 50 drachmai is allocated from the common funds (Il. 23-4: κοινοῦ ἀργυρίου, *Koinon argyriou*). The cost of the crowns and statues is also to be covered by the common funds (l. 35: κοινῶν χρημάτων, *koinon chrematon*).

XI. INTERACTION

ii. Interaction abroad

If the reconstruction of the text in lines 24-6 is correct, a copy of the honorary decree had to be sent 'to the fatherland' (Il. 25-6: [εἰς τὴν πατρίδα, *[eis ten patri]da*; following Holleaux 1899: 10-11, no. 10). If the words τῶι κοινῶι in line 26 are to be interpreted as a reference to a *koinon*, it may mean that a copy of the decree had to be sent to another association. The relevant lines of the inscription (Il. 24-6) are only partly preserved, and the restoration and interpretation are therefore uncertain. See above: 'Descriptive terms'.
