i.b. Document(s) typology & language/script	Greek dedication to the god Asklepios, followed by a list of members.

i.c. Physical format(s)	There are conflicting reports about the original shape of the monument (square block?, altar?, a base for offerings: see the discussion in Humphreys 2007: 65.
ii. Source(s) provenance	Seen in the church of Hagios Demetrios in the area of Megale Avle, to the northwest of modern Keratea. Today is considered lost.

Note	Sixteen names.
iii. Age	Adults
iv. Status	All are citizens, members of the deme of Prospalta.
v. Relations	All members seem to belong to c. 6 different families, on the basis of their patronymics, see already Ferguson 1944: 91 and in more detail Humphreys 2007: 74-5 with stemmata of the individuals mentioned.

iii. Worship	The group set up a dedication in honour of Asclepius.
