ii. Meetings and events	It is worth pointing out the phrase <i>ἐν τῷ θιάσῳ</i> ( <i>en toi thiasoi</i> ) in SEG 22: 122, l. 5. It was interpreted (Poland 1909: 17; Ferguson 1944: 93; Malouchou 2019: 79-80) as reference to the group, but I think it is more likely to denote the meeting place of the group (Arnaoutoglou 2003: 64-65).
