ii. Leadership	There is only a heavily restored reference to an individual whose name follows that of the polis' eponymous archon.

iv. Officials	Guardian of laws (<i>νομοφύλαξ</i> , <i>nomophylax</i> , Agora XVI 324, l. 6), on the magistracy see Poland 1909: 404. Priest (<i>ἱερεὺς</i> , <i>hierous</i> , Agora XVI 325, l. 7).

ii. Gender	Men
Note	Names of three male individuals are preserved, although only fragmentarily.
iii. Age	Adults
iv. Status	Probably all foreigners.

X. ACTIVITIES

i. Assemblies	The association held monthly meetings called main assemblies (ἀγορᾶι κυρίαι, <i>agorai kyriaei</i> , Agora XVI 324, ll. 3-4; Agora XVI 325, ll. 3-4) on the twentieth day of the month <i>Skirophorion</i> (June/July) on the premises of the group.
iii. Worship	The association's priest performed sacrifices (θυσίαι, <i>thysiai</i> , Agora XVI 325, ll. 9-10).
Deities worshipped	Μεγάλοι Θεοί, <i>Megaloi Theoi</i> , Agora XVI 325, l. 8. Ἀ[φροδίτη?], <i>A[phrodite]</i> , Agora XVI 325, l. 8.

i. Comments	Agora XVI 324: Passed in the archonship of Dionysios <i>ho meta Paramonon</i> . Agora XVI 325: Passed in the archonship of Sosikrates.
