Claudius Piso Mithridatianus (II), who have donated oil and money during their respective terms of office. In both cases, the honors are conveyed by the council, the people and the resident Romans. The association is only responsible for the inscription, using its own money (ἐκ τῶν ἰδίων, ek ton idion, Il. I.13-I.14 and l. II.20).
