In this case the amount of crops, which the debtor Nechoutes agreed to return for the loan in the month of Pachon of 14th year of Ptolemy X Alexander I (15 May $-$ 13 June 100 BC), i.e. usually after the harvest, was seven and a sixth artabae of barley (ca 280 litres = ca 215 kg). |
