i. Name in other forms	Δαμυίδαι ? (IG XII.5 872, l. 28: presumably the same group as the <i>koinon</i> ; hence the restoration [Δαμυι]δῶν in ll. 24-5; see XII.i: 'Comments') -- shorter, without <i>koinon</i>
ii. Name elements	Cultic: <i>thiasitai</i> ? (restored)  Personal: <i>Damyidai</i> ? -- It is possible that the name refers to an ancestor or founder (cf. Dareste et al. 1898-1904, vol. 1: 94); older eds. read Damyiadai (see XII.i: 'Comments').

## VIII. PROPERTY AND POSSESSIONS

i. Treasury/Funds	The <i>koinon</i> together with three individuals (from the <i>phyle</i> of Thryesioi) bought a house which seems to have cost 1.287 drachmai and 4 obols (IG XII.5 872, l. 26, total sum reconstructed on the basis of the amounts mentioned in ll. 27-28; cf. Étienne 1990: 70). If the identification of the <i>koinon</i> with the Damyidai (l. 28) is correct, they covered 510 drachmai, while the Thryesioi covered 777 drachmai and 4 obols.
ii. Realty	The <i>koinon</i> together with three individuals bought a house ( <i>oikia</i> ) in the city ( <i>en astei</i> ), in the second 'quarter' ( <i>en tonoi deuteroi</i> ); the names of the neighbours are mentioned, but the stone is damaged at this point (IG XII.5 872, ll. 25-26).

## XI. INTERACTION

i. Local interaction	The <i>koinon</i> bought a house together with three individuals from the <i>phyle</i> of Thryesioi (IG XII.5 872, ll. 25-26). The two sellers are from the <i>phylai</i> of Donakeis and Gyraeis (l. 25). The four <i>prateres</i> (guarantors) are from the <i>phylai</i> of Hiakintheis, Thryesioi, Gyraeis, and the city <i>phyle</i> (ll. 26-27).

## XII. NOTES

i. Comments	<p>Older eds. (following Newton in GIBM II 377) read Δαμιαδῶν, <i>Damyadon</i>, rather than Δαμιδῶν, <i>Damyidon</i> (IG XII.5 872, l. 28) and restore the name of the <i>koinon</i> as κοινὸν θι[ασιτῶν Δαμι]ιαδῶν, <i>koinon thiasiton Damyjandon</i> (ll. 24-25).</p> <p>The house purchase in which the <i>koinon</i> is involved took place in the month Heraion (IG XII.5 872, l. 22).</p> <p>There are similar attestations of associations elsewhere in the text: IG XII.5 872, l. 60 (<a href="#">CAPIv. 864</a>), l. 76 (<a href="#">CAPIv. 865</a>), ll. 114, 115, 116-117, 118 (<a href="#">CAPIv. 866</a>).</p>

Note	<p>While the use of the term <i>koinon</i> and the involvement of the group in the buying of property make it very likely that this is an organized body (with funds), the name of the group relies on restoration and it is difficult to say whether the <i>koinon</i> should be considered 'private'.
