iii. Members	The members were perhaps usually called φίλοι (<i>philoí</i> , "friends"), since in SEG 29: 1195 the guild erects the epitaph for its "friend". Cf. Herrmann 1962: 17, no. 58; Bakir-Barthel and Müller 1979: 171, no. 29.
viii. Obligations	The association probably had some funerary obligations towards its members.

VIII. PROPERTY AND POSSESSIONS

i. Treasury/Funds	The association must have funds in order to bury or erect funerary inscriptions to its members.
