ii. References to buildings/objects	Reference to a stele in l. 13 is restored by Wilhelm 1905, ἀναγρά[ψαι] δὲ τόδε τὸ ψή[φισμα ἐν στήλῃ λιθίνῃ], <i>anagra[psai] de tote to pse[phisma en steli lithinei]</i> .

VII. ORGANIZATION

ii. Leadership	In l. 5 there is a reference to leaders, ἡγεμόνες <i>hegemones</i> . According to the text they coordinate their actions with that of the honoured officials, but their name implies some sort of preeminence.
iv. Officials	Treasurer (<i>ταμίας, tamias</i> , ll. 9, 15) Steward (<i>ἐπιμελητής, epimeletes</i> , l. 9) Secretary (<i>γραμματεύς, grammateus</i> , l. 9) Comptroller (<i>ἀντιγραφέύς, antigrapheus</i> , ll. 9-10) Record-keeper (<i>γραμματοφύλαξ, grammatophylax</i> , l. 10)
vi. Laws and rules	In l. 2 there is an oblique reference to a law (<i>νόμος, nomos</i>), something that led Wilhelm 1905 to restore <i>nomos</i> in l. 3 in order to explain the obligation of the officials honoured to provide money for the burial of the deceased members, ll. 2-3: ἔδοσαν [δὲ καὶ ταφικόν τοῖς μεταλλάξαν τὸ γεγραμμένον ἐκάστων κατ[ὰ τὸν νόμον] <i>edosan /de kai taphikon this / metallaxasin to gigrammenon hekastoι kat[ā ton nomon]</i>].
ix. Privileges	Apparently, the association provided a benefit for burial to its deceased members (ll. 2-3).

VIII. PROPERTY AND POSSESSIONS

i. Treasury/Funds	In ll. 3-4 is mentioned that the honoured officials have handed down an amount of more than 1770 dr.: [καὶ πα ρα]δε[δ]ώκασι[v] ἀργυρ[ι]ου περὶ τοὺς Χ?HH?ΔΔ, [<i>kai pa ra]de[d]okasi[n] argyri]ou perion 1770.</i>

ii. Gender	Men
Note	The attested names of members are male names.
iii. Age	Adults

X. ACTIVITIES

iii. Worship	A sacrifice (<i>θυσία, thysia</i>) is restored in l. 17. The reference to piety towards the gods (ll. 12-13: [καὶ εὐσέβειας τῆς περὶ τοῦ] ς θεοὺς, [<i>kai eusebeias tes peri tou]/s theous</i>]) imply that the group had, among others, a cultic function.

iv. Honours/Other activities	<p>The officials are honoured with a praise (ἐπαινέσαι, <i>epainesai</i>, l. 8) and a crown of olive leaves (θαλλοῦ στέφανος, <i>thalou stephanos</i>, l. 11).</p> <p>The treasurer of the year of archon Glaukippes is ordered to provide the sum of 30 dr. for a dedication and a sacrifice, ll. 15-17.</p>

i. Comments	<p>The decree was substantially restored by Wilhelm 1905. The ascription to an association of <i>thiasotai</i> relies on his reading in l. 8 of a (uncertain) theta.</p> <p>In l. 16 the name of the archon Glaukippes survives.</p>
