ii. Name elements	Professional:	<i>Leukogeitoi</i> -- Perhaps to be interpreted as whitewashers?
	Theophoric:	<i>Leukotheai</i> (Nereids) ? -- It has been suggested by Shields (1917: 43) that the term <i>Leukogeitoi</i> might relate to the Nereids, known on Lesbos as <i>Leukotheai</i> .
	Topographical:	<i>Leukogeitoi</i> -- Perhaps inhabitants of a neighbourhood, as suggested by Harland online (see AGRW ID# 12288).

XII. NOTES

i. Comments	Based on letter forms, IG XII.2 481 must date to the (later) Imperial period (cf. Ziebarth 1900: 509-10, no. 2), perhaps iii AD (Shields 1917: 43, n. 41). The case of $\theta\acute{\alpha}\sigma\omega$, <i>thiaso</i> , in IG XII.2 481, l. 2 is dative and not genitive: IG XII Suppl. p. 29.
