Crowning the statue of the king Ariarathes, Aneziri no. A3, l. 36. The celebration of an ἐπόνυμος ἡμέρα, <i>eponymos hemera</i> is prescribed in Aneziri no. A3, ll. 38-42. |

| ii. Interaction abroad | The association maintained friendly relations with Delphi and the sanctuary of Apollo. It enjoyed protection and exemption from seizure, tax, and conscription (ἀσυλία, ἀτέλεια, ἀσφάλεια, ἀστρατεία, <i>asylia, ateleia, asphaleia, astrateia</i> , Aneziri no. A5, ll. 8-15, 75-76, 80-84), was granted priority in consulting the oracle and exemption from seizure (προμαντεία, ἀσυλία, <i>promanteia, asylia</i> , Aneziri no. A6, l. 34), in leading a procession and proxeny (ἀσυλία, προμαντεία, προπομπεία, προξενία, <i>asylia, promanteia, propompeia, proxenia</i> , Aneziri no. A10, ll. 41-42 and Aneziri no. A11, l. 66). The king of Cappadocia Ariarathes granted to the <i>technitai</i> inviolability (ἀσυλία, <i>asylia</i>), security (ἀσφάλεια, <i>asphaleia</i>), exemption from tax and duties (ἀτέλεια, <i>ateleia</i>), Aneziri 44-46. Also the association petitioned (Aneziri no. C1Ba, ll. 25-28) and was granted the right for their priests to wear a crown (στεφανηφορεῖν, <i>stephanephoreïn</i>) and χρυσοφορεῖν τοῖς θεοῖς, <i>chrysophoreïn tois theois</i> , Aneziri no. C1Ba, ll. 30-32; Aneziri no. C1Ac, l. 26. For an assessment of the privileges awarded to the association see Aneziri 243-52. For the meaning of <i>chrysophoreïn</i> as wearing a golden insignia see Kuhn 2014: 55-8. Another dimension of the interaction of the group is the bitter controversy with the <i>technitai</i> of Isthmos in the late second century BC and the resolution of the dispute by the Roman Senate, details in Le Guen I 102-5 and Aneziri 306-16. |

In the paeon Le Guen 2001: 16-7 the group is described as ὁ δὲ τεχνιτῶν πρόπας ἔσμός, <i>ho de techniton propas hesmos</i> . Inscription Agora XVI 296 (161/60 BC) is associated by its editor to the group of <i>peri ton Dionyson technitai</i> , on the basis of <i>Dionysiakon</i> , l. 105 and the phrase πρὸς τὰς τῶν συνόδων χρείας, <i>pros tas ton synodon chreias</i> , l. 14. However, the plural <i>synodoi</i> does not signify the association but the meetings. |

The association displays all the hallmarks of a private association: distinct name, membership, organization, property and durability.
