Privileges	The privileges granted by Mummius are likely to be similar to those granted to the Isthmian <i>technitai</i> : exemption from liturgies, <i>ateleia</i> , exemption from taxes for themselves, and for their wives and children until they become adults. On Mummius and the <i>technitai</i> : Le Guen II: 25-6.

XII. NOTES

i. Comments	On these <i>technitai</i> gathered around Dionysos <i>Kethegemon</i> , see Le Guen II: 29-34. The identification of the Roman magistrate as Lucius Mummius is not universally accepted: see for example Sherk 1969, who dates the text to the latter part of the second century BC, while Aneziri prudently refers to a Roman consul. Roesch 1982 and Le Guen I argue in favour of Mummius himself.
